Qualifications: REALTOR® membership in good standing with any Shareholder of the Corporation. Shareholder Board/Associations include: East Central Board of REALTORS®, Franklin County Board of REALTORS®, Greater Gateway Association of REALTORS®, Lebanon Board of REALTORS®, Mineral Area Board of REALTORS®, Mark Twain Association of REALTORS®, Pulaski County Board of REALTORS®, REALTORS®, Southeast Missouri REALTORS®, Southern Gateway Association of REALTORS®, St. Charles REALTORS®, St. Louis REALTORS®, and Three Rivers Board of REALTORS®. Candidates for office must be affiliated with a firm not designated as one of the three largest brokerage firms based on the total participants and subscribers associated with Mid America Regional Information Systems, Inc. This notice has been sent to your firm as a member of a brokerage not designated as one of the three largest firms.

Geographic categorization. Per MARIS Bylaws, an area is considered "Urban" if it has a population of 50,000 or more; and an area is considered "Suburban" if it has a population of at least 2,500 and less then 50,000; and an area is considered "Rural" if it has a population of less than 2,500, or if the area is unincorporated; an area is considered "Resort" if it has a recognized tourist attraction or vacation destination or is not classified as Urban, Suburban, or Rural. Populations shall be determined by the most recently available information from the U.S. Census Bureau. The foregoing default categorizations are utilized as guidance for self-classification when a nomination is submitted; all self-classification is subject to the Credential Committee's powers provided in Section 6.5(c).

October 12, 2021	Email from Vote-Now to all eligible participants with candidate's biographies, (listed alphabetically) election date, time, and ballots.
November 1, 2021	Ballots must be cast by 12:00 pm (Noon) to be counted for the 2022 election of Directors.

The Board of Directors shall appoint a Credentials Committee of six (6) participants.
